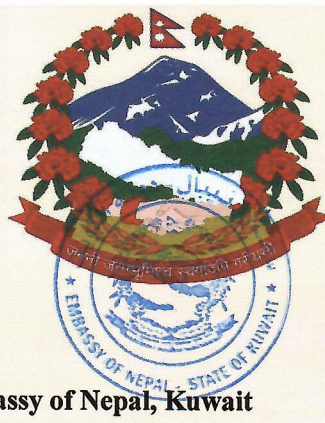

Disposal of Furniture and Electronic Items

The Embassy of Nepal in Kuwait is going to dispose of old furniture and electronics items through a sealed bid process on "as is where is" basis, without any guarantee regarding their condition or quality.

Sealed bids are invited from interested firms or individuals for these items under the terms and conditions set by the embassy. Prospective buyers should submit their quotations using the form provided by the Embassy. Sealed quotations should be addressed to the Embassy of Nepal, Kuwait City and must be submitted to the Embassy by 1:00 pm on 25 January 2026. The sealed quotations will be opened at 3:00 pm on the same day in presence of bidders or their representatives. However, the absence of bidders or their representatives will not prevent the opening of the sealed bids.

All the listed items are available for inspection between 1:00 pm to 3:00 pm on working days from 19 January 2026 to 24 January 2026. An appointment for the inspection may be scheduled by email (eonkuwait@mofa.gov.np) or phone (+96561008956).

Terms and Conditions

1. All furniture and electronic items will be sold in bundle.
2. Bids below the minimum amount will not be accepted.
3. Bidders must pay a Bid Security Deposit (Refundable) of 10% of the quoted amount. Security deposit will be fortified if the successful bidder fails to deposit the bid amount and remove the items in stipulated time. Quotations submitted without the security deposit will not be accepted.
4. The Bid Security Deposit shall be directly deposited into the Account Name: **Embassy of Nepal** Account Number **2012837349** at the National Bank of Kuwait.

5. A Bid form may be purchased from the Embassy upon payment of a non-refundable fee of KWD 3.000 till 24 January 2026 during office hours.
6. The successful bidder must deposit the bid amount directly into the specified bank account of the Embassy within 5 (five) working days of receiving the official notice of bid acceptance.
7. The Security Deposit will be released only after the entire sales process is completed. The Security Deposit will not be adjusted against the sale proceeds and will be fortified if the successful bidder fails to honor the bid.
