4. Electronic bids must be submitted through PPMO website [www.bolpatra.gov.np/egpon](http://www.bolpatra.gov.np/egpon) or before 10:00 hours on 2026/04/29. Bids received after this deadline will be rejected.
5. The bids will be opened in the presence of Bidders' representatives who choose to attend at 11:00 hours 2026/04/29 at the office of Division Forest Office, Sunsari. Bids must be valid for a period of 90 days from the bid submission deadline and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of 1,00,000.00, which shall be valid for 30 days beyond the validity period of the bid.
6. If the last date of purchase and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
