5. Pre-bid meeting shall be held on **28 September 2025** at the address given below at 14.00 hrs.
6. Electronic bids must be submitted to the office through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before **12.00** hrs **9 October 2025**. Bids received after this deadline will be rejected.
7. Bids will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below at 12.30 hrs on **9 October 2025**.
8. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a scanned copy of the bid security in pdf format, amounting to a minimum of for NPR **542,000.00** issued by "A" class commercial Bank or Financial Institutions with
