5. Pre-bid meeting shall be held at Department of Postal Service, Babarmahal, Kathmandu, Nepal at 14.00 o'clock of **25, Falgun, 2082**.
6. Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by bid security, amounting to a minimum of NRs. 5,20,300.00 (Five lakhs Twenty Thousands Three hundreds only), which shall be valid for minimum 30 days beyond the bid validity period.
7. Electronic bids must be submitted to the office of Department of Postal Service, Babarmahal, Kathmandu, Nepal through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12.00 Noon of 5, Chaitra 2082. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14.00 PM of 5, Chaitra 2082 at the office of Department of Postal Service, Babarmahal, Kathmandu.
9. If the last date of purchasing and/or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
10. Department of Postal Service reserves the right to amend or correct and reject wholly or partly or the entire bid proposal without assigning any reasons, whatsoever. The matter not specified in this notice and the bidding document follows the prevailing laws of Nepal i.e. Public Procurement Act, 2063 B.S. and other nepalese law.
