The quoted price must be in United Arab Emirates Dirham (AED) and should reflect full diplomatic privileges.

Proposal for the Procurement of a vehicle

The Embassy of Nepal in Abu Dhabi invites proposal from eligible and qualified bidders for the supply and delivery of one (1) **Sedan Car** as per the specifications attached in this document. The vehicle will serve as the official flag car for H.E. the Ambassador of Nepal.

1. Scope of Procurement

The procurement includes the supply and delivery of one (1) new Sedan Car that meets the required specifications (Specifications attached). The vehicle must be equipped with high-end safety features, a premium interior, and the latest technological advancements to ensure maximum comfort, security, and efficiency.

2. Conditions of Contract

- The supplier shall ensure the delivery of a brand-new vehicle with zero mileage (except for transportation purposes).
- The vehicle must comply with emission norms and be suitable for operation in the UAE.
- The supplier must ensure that the vehicle is free from any defects at the time of delivery.
- The Embassy reserves the right to reject any vehicle that does not meet the agreed specifications or standards.

3. Qualification Requirements

Eligible bidders must meet the following criteria:

- Must be an authorized dealer or distributor of proposed car.
- Must have at least 5 years of experience in the automobile supply business.
- Must provide a valid trade license.
- Must have a valid after-sales service network in the UAE, with service centers easily accessible.
- Bidders must submit a manufacturer's authorization certificate if they are not the manufacturer.

4. Evaluation Criteria

The bids shall be evaluated based on the following criteria:

- Technical Compliance: The vehicle must meet or exceed the specifications provided.
- Price Competitiveness: The total cost, including delivery and taxes will be assessed.
- After-Sales Support: Availability of service centers and warranty support will be considered.
- Delivery Timeline: Preference will be given to bidders who can deliver the vehicle within the shortest possible time.

5. Delivery Schedule

- The vehicle must be delivered by 13 June 2025.
- Delivery location: Embassy of Nepal, Abu Dhabi.
- The supplier must provide a detailed schedule of delivery and handover.
- In case of any delay, the supplier must provide prior notification with valid justification.



6. Warranty

- The supplier must provide a minimum of 5-year comprehensive manufacturer's warranty.

7. Submission of Bids

- Bidders must submit proposal by 30 May 2025 within office hours.
- The bid must include:
- Technical proposal with detailed specifications.
- Financial proposal including all applicable taxes and fees.
- Company registration documents.
- Proof of leadership dealership authorization.
- Warranty details.
- Bids received after the deadline will not be considered.

8. Rights of the Embassy

The Embassy of Nepal reserves the right to:

- Accept or reject any or all bids without assigning any reason.
- Negotiate terms with the selected bidder before awarding the contract.
- Cancel the procurement process at any stage if deemed necessary.

9. Payment Terms

- 100% of the quoted amount will be paid upon confirmation of the availability of the vehicle for delivery. The supplier must ensure the fulfilment of the required technical specification before payment.

10. Proposal Evaluation Process

- The evaluation process will involve technical review, financial comparison, and verification of bidder qualifications.
- The winning bidder will be notified within 15 days and will be required to sign a formal contract.
