



### Call for Manuscripts

Ministry of Agriculture and Livestock Development, Food Security and Food Technology Division (FSFTD) announces interested author(s) to submit relevant manuscripts for publication in the forthcoming issue (vol. 27) of the **Journal of Agriculture and Environment**. The author(s) should base the manuscript on issues of *Agriculture system of Nepal and Environment/climate change/food and nutrition security/food safety/agricultural biodiversity/agricultural trade and food policy/Agriculture Commercialization/ Mechanization/Digitalization/ Use of AI/gender and social inclusion*. The author(s) should firmly follow the journal's agreed guidelines and submit it electronically at [agrijournal@moald.gov.np](mailto:agrijournal@moald.gov.np) before 30<sup>th</sup> Falgun, 2082 (14<sup>th</sup> March, 2026).

#### Guidelines for the author(s):

The Journal of *Agriculture and Environment* is devoted to the cause of advancing understanding of the various aspects of Agriculture through literature review, theoretical analysis, research, and practical experiences. Besides research and review papers, the journal may arrange spaces for case study, methodological approach, book review, report on seminar and meeting, short communication, and letter to the editor. Authors are requested to follow the following guidelines on the preparation and submission of a manuscript.

1. The manuscript must be an original work written in English and not published elsewhere.
2. The title should be short and specific, but it should reflect the contents of the manuscript.
3. The abstract should be in **Times New Roman** font (italics) 11-point font size, not exceeding 200 words, and should concisely state the major objective, methodology, findings, and conclusion. It should not include a diagram, a footnote, an equation, or any parenthetical references.
4. (Italic) in alphabetical order should not exceed five standard words.
5. The main text of the technical manuscripts should include heading, abstract with five keywords, introduction, methodology, results and discussion, recommendation, conclusion, and references. If any institution or individual has provided any kind of support (financial, technical, or otherwise) for the research work, the supporter or donor must be acknowledged at the end of the article
6. The manuscript should not exceed 4500 words in total. It should be in MS Word with pages set on A4 size, the top and left margins at 3 cm, and the right and bottom margins at 2.5 cm. The text format should be on **Times New Roman** font, 11-point size, single-spaced and **double columned**. Authors are encouraged to use the following **Microsoft Word-template** to prepare the manuscript.
  - a. The title of the manuscript, set as HEADING 1 (paragraph style), should be all capitalized in bold 12-point font size.
  - b. Name of the author(s) should follow the title in a new paragraph in normal 10-point font size, bold.
  - c. The level 1 headings should be all capitalized and bold 11- point font size. The level 2 headings should be bold, italic, and the first letter capitalized and in a bold 11- point font size. The level 3 headings should be in sentence case, italicized, and normal.
  - d. In tables, borders should be minimized, and text and numbers should be in a 9-point font size.
  - e. Bibliographic entries in the reference should be in a 9-point font size.
7. The number of footnotes should be minimized, and they should not be cited.
8. Many/big tables and figures in the text should be avoided. Supplementary figures and tables may be placed in the annexure.
9. Whenever possible, SI Units (International System of Units) should be used.
10. Images, should be in any of the PNG/JPEG/ TIFF/GIF diagrams should be of high-quality illustrations and in editable form. Written text in an image should be clear and easy to read, and located only at the top or bottom of the page.
11. APA 7th referencing style should be used and must be individually listed in alphabetical order at the end of the manuscript.
12. Following editorial scrutiny, the manuscripts are subject to rigorous peer review.
13. The Editor-in-Chief and the Editorial Board are not responsible for any damage or loss of submitted manuscripts and return of unaccepted manuscripts to the authors, whatever.
14. The Editor-in-Chief deserves the final right to accept or reject a submission.
15. Previous issues of the journal are available at <http://www.moald.gov.np>.
16. Manuscripts that do not correspond to the above mentioned instructions can be returned without review.
17. Other provisions should be followed as guided by "The Journal of Agriculture and Environment Publication Procedural 2082".
18. The manuscript should follow the provisions stated in this guideline, and for matters not mentioned here, it must comply with the APA 7th Edition.

Nepal's agricultural systems and environment; climate change and the agricultural sector; agricultural biodiversity; food and nutrition security, along with food hygiene; agricultural trade policy; commercialization and mechanization of agriculture; the use of digitalization and artificial intelligence in agriculture; and gender issues in agriculture. Policy analysis will be prioritized in these areas, and in addition, the editorial board may add further subject areas as deemed necessary before journal publication.
