The bids will be opened in the presence of Bidders' representatives who choose to attend at **10-02-2026 14:00** at the office of Health Directorate, Lumbini Province, Rapti Upateka Bhalubang Dang. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of Rs. 50,000, which shall be valid for 30 days beyond the validity period of the bid (i.e. [Refer Clause 1TB 20.1]). If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit Account No.[3120100202030000] at Nepal Bank Ltd Sisahaniya Branch *and submit the receipt of the deposited amount of cash along with the Sealed Quotation.*
